# SOCIETE GENERALE SECURITIES SERVICES RECEIVES SIXTEEN RATINGS FROM GLOBAL CUSTODIAN

Societe Generale Securities Services (SGSS) has **received sixteen major ratings** in Global Custodian's "Agent Banks in Major Markets Survey 2014" published in September 2014.

Rated among its peers, SGSS was named:

- "Global Outperformer"\* & "Market Outperformer"\*\* in France and "Category Outperformer"\*\*\* in 4 categories: Settlement, Asset Servicing, Relationship & Client Service, and Technology,

- "Market Outperformer" in South Africa,
